#### **Call for Papers**

**Rethinking Water Governance: Empowering Women for a Water-Secure Future** Organized by the ICID Task Force on Women Empowerment in Water Management (TF-WEWM), this workshop places women's creative, technical, and strategic capacities at the center of global water stewardship. We explore meaningful impact through three core pillars:

- 1. Strategic Governance & Institutional Leadership:** Advancing women from technical roles to high-level decision-making; building robust cooperation networks; and leveraging water diplomacy to accelerate the SDGs.
- 2. Climate Resilience & WEFE Nexus:** Integrating traditional water knowledge with Nature-Based Solutions (NbS); driving innovative governance in the Water-Energy-Food-Ecosystem (WEFE) Nexus; and fostering joint leadership for climate adaptation and resource optimization
- 3. Sustainable Economy & Digital Justice:** Unlocking green finance and micro-credits for women-led initiatives; and utilizing AI and smart technologies to bridge the digital divide, breaking the "glass ceiling" in water management

#### **Objectives**

- To showcase successful global experiences in transitioning women from technical roles to high-level strategic leadership.
- To facilitate institutional transformation by integrating Gender-Responsive Water Governance and Nexus models.
- To bridge the gap between international policy and local implementation (Local to Global) through knowledge sharing and networking.
- To accelerate the achievement of SDGs by showcasing successful models in climate resilience, digital innovation, and green finance.

#### **Scope**

As the ICID Task Force on Women Empowerment in Water Management (TF-WEWM) enters its third year of activity, this workshop focuses on the urgent necessity of revisiting current governance practices to address the global water crisis. Building on the successful outcomes of the Kuala Lumpur sessions, this event aims to enhance the quality of decision-making by integrating women's creative insights into the heart of water stewardship. The scope moves beyond technical discourse to emphasize Meaningful Influence through three

strategic pillars: it first addresses Strategic Governance and Institutional Leadership, showcasing the transition of women from traditional and technical roles to high-level decision-making while emphasizing the strengthening of cooperation networks at local, national, and international levels to enhance social and institutional resilience and utilizing soft skills such as Water Diplomacy to accelerate the achievement of the Sustainable Development Goals (SDGs). Furthermore, the workshop delves into Climate Resilience and WEFE Nexus from a management perspective, highlighting the vital role of integrating indigenous water culture and traditional knowledge with Nature-Based Solutions (NbS) to increase the resilience of watersheds, while presenting innovative models in Water-Energy-Food-Ecosystem (WEFE) Nexus management to demonstrate how the joint leadership of women and men leads to resource optimization and climate adaptation in both small and large-scale farming. Finally, this scope bridges the intersection of Sustainable Economy and Digital Justice, exploring economic empowerment through Green Finance, micro-credits, and international donor engagement, alongside leveraging Artificial Intelligence and smart technologies as essential tools to break the glass ceiling, ensuring that digital innovation serves as a catalyst for bridging the gender gap in global water management; this comprehensive approach ensures that the workshop acts as a driver for economic growth, environmental sustainability, and a water-secure future for all.
